REQUIREMENTS:

1. All tree contractors must be registered with the Village of Lloyd Harbor. No permit will be issued for an unregistered contractor. Contact the Village Clerk's office @ (631) 549-8893 for a list of registered tree contractors.
2. All trees to be removed shall be marked with a **RED** ribbon only. **Ribbon available at Village Hall for \$3/roll.**
3. Applicant may remove up to 18 trees with a circumference of 12.5-inches or greater within a 36-month period. Removal of more than 18 **REGULATED** trees within a 36-month period, requires Permit Review Board approval.
4. A Permit is required for the removal of more than 18 **UNREGULATED** trees, less than 12.5 inches in circumference within a 36-month period.
5. Tree removal is NOT part of construction, please **check box** ☐
6. Provide a sketch on back of this form indicating location & size of trees to be removed.

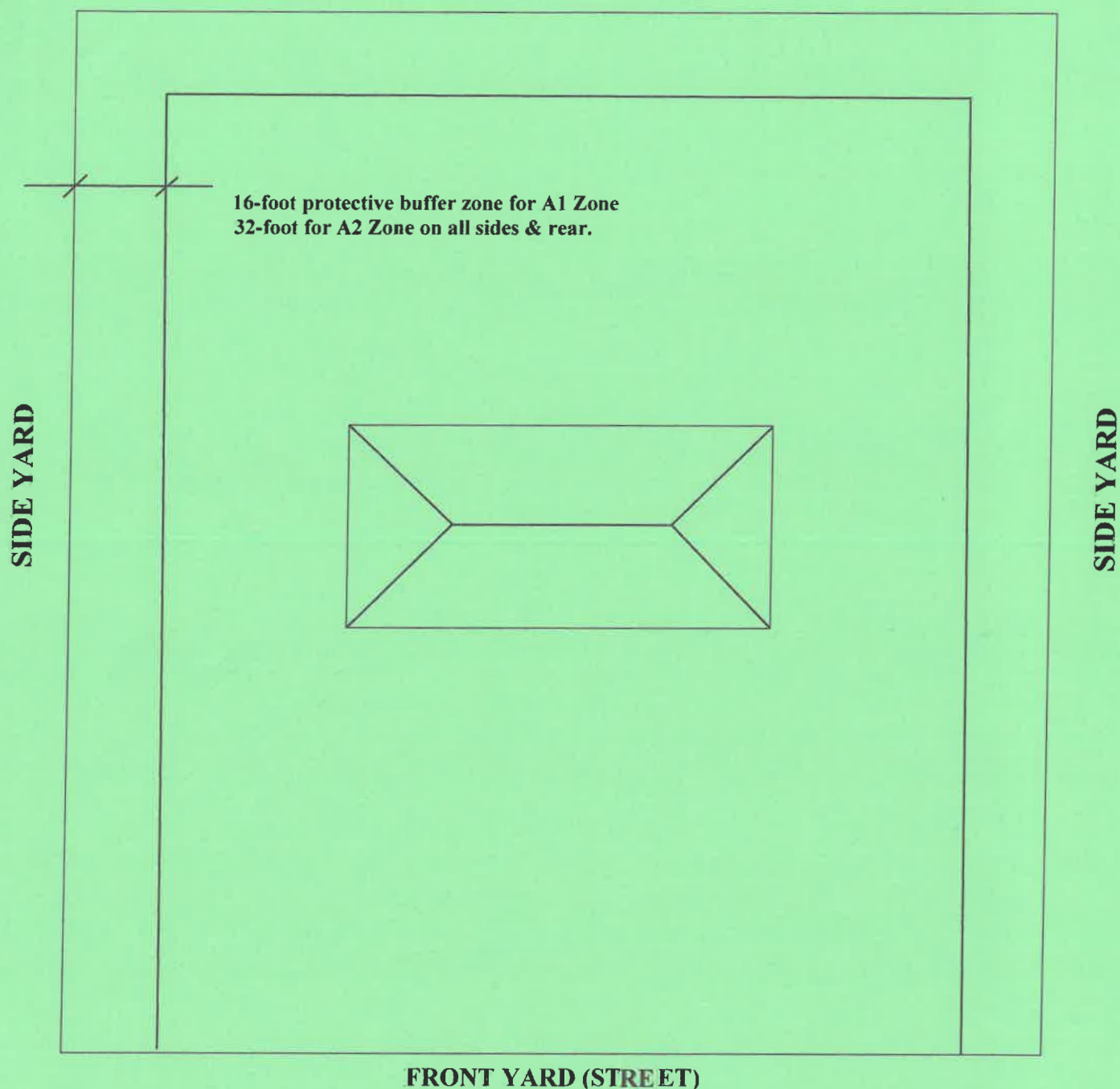
